**Rental Space Fees:** Are formulated by the size of booth or trailer including the hitch. Less than 10ft. \$60 per day, 11ft-15ft \$72.50 per day, 16ft-30ft. \$85 per day. Over 31 Ft. \$100 per day.

**Non-Profit Rental Fees:** All non-profits are required to provide proof of their non-profit status. Less than 10ft \$30 per day, 11ft-15ft \$42.50, 16ft-20ft \$55 per day, Over 31ft. \$80 per day.

*In order to bring more potatoes to the Maine Potato Blossom Festival, we are offering **30% off your vendor fee for featuring at least one original potato-based menu item** (French Fries and bagged potato chips don't count!), and an additional 10% off your space fee for each additional unique potato offering, awarded on a first-come, first-granted basis. Additionally, vendors with potato-themed items will be automatically entered into a "Best Potato Dish" competition to win a free rental space at next year's festival!*
